As 2017 and Guatemala’s CIAR training event gets closer, I’ve sought the Lord for insight and wisdom on how to prepare. Although my heart’s desire is to return multiple times, realistically, returning for repeat events in Guatemala may not be as easy or frequent as in the US. With the thought of “one shot” in mind, I felt a sense of urgency to create another video as a training prerequisite. FMM’s **“Family of Videos”** serves to prepare CIAR participants and reinforce recovery principles long after an event. This Family of Videos now consists of five. The first introduces trauma model or Core Issue Addiction Recovery followed by Sexual Addiction Statistics, the L.I.F.E. Recovery Model (LRM), the LRM Evaluation Tool and, the newest video, the [Reflective Listening Exercise](#). The Reflective Listening Exercise ([pdf download here](#)) is an effective tool to teach expressing feelings, processing pain, discovering unmet needs and action steps to get that need met in healthy ways. **Update by Month**  
**October**

FMM partners with Georgia Criminal Justice Coordinating Council on their Demand Reduction workgroup. Our workgroup, along with BEST (Businesses Ending Slavery and Trafficking), spent 2015 planning and preparing the presentation. This free Lunch and Learn on the “Impact of Human Trafficking on Businesses” was held at the Loudermilk Center in Atlanta on Friday, October 14th of 2016. Dozens of business leaders attended to increase their awareness of human trafficking, with many organizations either currently engaged or began the next steps to combat this social issue. Even still, most business leaders are not aware that through their policies they can actually impact demand for sex trafficking and at the same time, reduce potential risk to their company. FMM is a proud recipient of Georgia’s CJCC Certificate of Appreciation for Demand Reduction efforts in 2016.



**November**





### Forgiven Much Ministries (FMM)


### Demand Reduction (DR) Initiatives

Committed volunteers are needed to communicate DR initiatives in local communities i.e. speaking in churches/faith communities about DR strategies including the implementation of buyers' schools (for purchasers of adult commercial sex) which funnel participants toward local support groups for further healing on the recovery journey. Every community needs

more [L.I.F.E. Recovery Groups](#) and could benefit from [CIAR Training](#) to provide a biblical and clinical foundation of the addictive condition and the healing journey.

## GOHTTF (Orlando) – DR Subcommittee:

As E4HI (our buyers’ reform school for purchasers of adult commercial sex) approaches its launch date, the Demand Reduction focus returns to the subcommittee and implementing the next initiative to build the General Population Presentation (GPP). Praise the Lord, He has brought two new volunteers with expertise and passion for the GPP! The GPP addresses both the public and faith community on its attitudes and actions that fuel s\*x trafficking. The GPP effort, along with FMM’s training that plants s\*xual addiction L.I.F.E. Recovery Groups and E4HI’s buyer reform efforts, offer what we believe to be a comprehensive community strategy to end human trafficking.
